Chair's Review

I am very pleased to present my review as Chairman of the Charity in the 2017-18 Annual Report and Accounts.

Our overall result this year has been a small operating surplus of just under £4,000, much in line with 2015-16 and 2016-17 and in line with our budget at the start of the 2017-18 financial year. Both income and expenditure were broadly in line with budget, although there were naturally variances in individual components of both income and expenditure. Income from funders often varies significantly from year to year and lost funding needs to be replaced by new sources of funding or increased funding from existing funders. In 2017-18, we were fortunate to receive an increased level of funding from the Sussex Police and Crime Commissioner and we are extremely grateful to Katy Bourne and her team for their continued support and encouragement. The increased funding from the Sussex Police and Crime Commissioner offset a fall in income from grants that concluded in 2016-17.

Ensuring that we maintain a stable level of funding is a very difficult task, and one which Nick Handley manages each year, despite the challenges of a tough financial climate. My thanks go to Nick for continuing to deliver on this key element of the Charity's business plan.

The other key element of our funding is through provision of paid services in the Family Mediation space. Here income levels were comparable with 2016-17. For the future, Heather Foster is now an accredited Family Mediator in her own right, and this should enable us to increase our revenues from this source. My thanks go to Robert Savage for his continued work for the Charity in this area, and to Heather for her perseverance with the accreditation process, and her work together with Robert on Family Mediation.

On the expenditure side, most items of expenditure were broadly in line with 2016-17, reflecting the more stable structure that we put in place during 2016-17. The one exception to this is the investment in a new IT system thanks to grant funding from Awards for All (Big Lottery).

The key metrics that allow us to measure activity within the service are the number of referrals received and the number of cases proceeding to mediation.

In 2016-17, community referrals were at a record level, so it is no surprise that 2017-18 levels were around 11% lower in total, with 318 referrals received compared to 357 in 2016-17. Of these 318, 142 were Family Mediation cases, virtually unchanged from 2016-17. This is a mixed blessing, as whilst it maintains income levels, it shows a decline in our core Community Mediation numbers. Again though, this must be viewed against the exceptional number of cases referred in 2016-17. We generally expect around 50% of referrals to proceed to formal mediations, and this has proved to be the case during 2017-18. I am confident that the number of actual cases proceeding to mediation will continue at least at the levels of 2017-18 into the future.

During the year, there have been several staff changes. Pam Chatterton, our long serving Case Worker retired in January after almost 12 years' service with the Charity. On behalf of the Trustees, I thank her for her contribution over that time. Her replacement is Karen Trushaden who is primarily managing Family Mediation referrals.

I think everyone now knows about GDPR (General Data Protection Regulation), particularly as most of us were hit by a tidal wave of communications from various organisations in the lead up to its implementation in May. The Charity, of course, must comply with the requirements of GDPR and this was a very significant and time-consuming task in the second part of the year. Here my thanks go to Nick and the staff for their efforts in ensuring that the Charity is GDPR compliant, but also in particular to former Trustee David Chubb who gave generously of his time as a volunteer to ensure that the Charity was prepared for the implementation of GDPR. During the year, we identified that the Constitution of the Charity, which has not been updated for a number of years, requires several minor changes to enable the Board of Trustees and Management Committee to operate effectively. These changes have been brought to the 2018 AGM for approval. Looking forward, it is also apparent that we should be changing the status of the Charity in the wake of GDPR and other legislative changes. We will look to do this without further changes to the Constitution and without disrupting the day to day work of the Charity at some point in the near future.

The Pan Sussex Alliance, which brings together the four mediation services in Sussex, continues to develop. Further meetings were held during the year to explore areas where we can all benefit from an across Sussex approach.

During 2017-18, we welcomed Steve Poulton (Treasurer) and Paul Minter (Secretary) to the Board. We also welcomed Monica Hill as a Trustee. David Chubb resigned as a Trustee during the year, and I thank him for the contribution he made to the Trustee Board, and I am pleased that he continues to work with Nick and the office staff on various initiatives.

Unfortunately, during the year, Steve Poulton resigned as Treasurer, but I am very pleased to welcome back as Treasurer, Allan Gee, who held the post prior to Steve and will need no further introduction.

As usual, I would also like to thank the mediators for all their hard work given on a voluntary basis to enable us to continue to provide Community Mediation services, free at the point of delivery, across West Sussex.

And finally, I would like to thank my fellow Trustees for their time given freely and their skills and knowledge, which have helped to steer the Charity through a difficult period and emerge stronger, and better able to deal with the challenges of the coming months and years.

Co-ordinator's Report

Our Chair has given a good review of the year reported, so I will try to avoid too many duplications. Whilst not as hectic as our record previous year (2016/17), the year reported kept us quite busy. We again managed to balance the booked through the tight control of our expenditure and the significant boost from our grant from the Sussex Police & Crime Commissioner. Without that support our financial position would be very different.

Earned income remains a vital source of revenue for the charity. In the year reported, we managed to match the amount achieved in 2016/17. This equated to 26% of our total income for the year. We had hoped to show continuing growth, but unfortunately that was not the case. We will therefore be looking at ways to reach a wider audience in 2018. Our fee-paying services are all well priced in comparison to the marketplace. Family Mediation is the primary earner in this respect and we are eternally grateful to our volunteer family mediators, Robert and Heather.

The various grants from Trusts and Foundations covered various projects. The Worthing Community Chest supported our Conflict Coaching scheme; the Gatwick Area Community Trust supported our Elder Mediation project; the Rank Foundation covered additional costs related to our IT upgrading, in support of our Awards for All grant. The WH Smith Foundation made a small contribution towards new office storage.

We managed to raise our fundraising income by organising more events. We held a very successful Barn Dance and a Curry Night during the year. We would dearly love to attract some volunteer fundraisers and event organisers to help raise more funds for us through community events. This would also help raise our profile.

Donations also increased, with two good donations from two Lions Clubs (Horsham and Bognor Regis). These donations helped us purchase some important items of equipment i.e. a secure metal filing cabinet and a powerful new shredder to help us with our GDPR compliance measures.

Fundraising expenditure appears inflated, but this included the purchase of a liveried events gazebo, valued at just over £1,000, which was funded towards the end of the previous financial year by One Stop (via Groundworks) – see picture gallery.

Our mediator numbers remained stable, although we did recruit further mediators in Oct/Nov 2017. The significant spend on training does include supervision sessions and CPD for our two family mediators alongside training for our new and existing community mediators. We sold one place on the last training course to an outside organisation and hope to generate more income from training provision in the future.

Will has mentioned the changes in office staff during the year. We hope that Pam Chatterton is enjoying her retirement. There have been more staff changes in recent times than we have experience in the past, partly due to increasing office hours with job sharing, to a degree.

As per the Chair's report, I wouldn't end my brief report without acknowledging the fantastic work carried out by all our volunteers. Through their work, we have been able to resolve many neighbour disputes, prevented situations from escalating, kept families together, settled workplace conflicts and helped divorcing/separating couples dissolve joint finances and make child arrangements, in a civilised way.






Total referrals - 5 year trend




Referral by Local Authority Area (2017/18)




Source of Referrals (2017/18)




5 year Trend - Fee Earning Mediation




Referrals by topic – Community & Intergenerational (IG)

Excerpts from our year - 2017/18

Outcomes – 33 Community mediations reached joint meetings with signed agreements, a further 2 reached a verbal agreement. 5 joint meetings did not result in agreements. Several cases from year end remain open into 2018/19. Many disputes were resolved by our interventions before formal mediation.

GDPR – just one of those things we all had to contend with, with much preparatory work done prior to the go live date – therefore within the reporting year. We are grateful to David Chubb (Trustee/Volunteer) for all his hard work on this subject. Bognor Regis Lions gave a donation, which paid for a new substantial shredder for the office so that confidential waste could be suitably destroyed (Aug 17).

Pam Chatterton (Caseworker) retired after long service with the charity. We held her send off on 10th Jan in Steyning.

Busy January – 45 referrals, which matched our previous record month (July 2016).

Awards for All (Big Lottery) - a grant of £3,470 allowed us to purchase four new computers, monitors and software for the office (Sept 17).

Fundraising events – such as our Barn Dance (Apr 17), Cream Tea (Jun 17) and Curry Night (Sept 17).

Work experience – we welcomed Viktorija, as Law & Business Studies student from Chichester College to the office. She came in once a week over an extended period, commuting from Worthing by train. She enjoyed her time with us, as we did hosting her. She remains a keen supporter of the charity.

New recruits – training course held in Oct/Nov 17 in Henfield and Billingshurst with a number of recruits graduating at the conclusion.

'Live Chat' facility added to our website – which has proved to very popular with the public (Sept 17).

New Promotional Gazebo –thanks to One Stop, we gained grant funding (£1,000) for a posh new, liveried Gazebo, through their Carriers for Causes scheme (sale of 5p carrier bags). This is being utilised at public events throughout the year. The design work was carried out by our favoured graphic designer, Hilary Bates (June 17).

GDB Charity Challenge – (May 17) an It's a Knockout' event at Ardingly showground which raised funds for WSMS and a number of other charities. GDB is a business networking group and we a charity member (www.gatwickdiamondbusiness.com)
